Quicken for Windows Conversion Instructions

Quicken for Windows 2013-2016

Express Web Connect

Introduction

As Farmers Insurance Group FCU completes its system conversion to Farmers Insurance FCU/Farmers Insurance FCU-Business, you will need to modify your Quicken settings to ensure the smooth transition of your data. Please reference the dates next to each task as this information is time sensitive. To complete these instructions, you will need your User ID and Password for the Farmers Insurance Group FCU and Farmers Insurance FCU/Farmers Insurance FCU-Business websites.

NOTE:

Quicken Web Connect/Express Web Connect accounts use the same **User ID and PIN/Password** as the Farmers Insurance FCU/Farmers Insurance FCU-Business website.

It is important that you perform the following instructions exactly as described and in the order presented. If you do not, your service may stop functioning properly. This conversion should take 15–30 minutes.

Documentation and Procedures

Task 1: Conversion Preparation

- Backup your data file. For instructions to back up your data file, choose Help menu > Quicken Help. Search for Backup Data File and follow the instructions.
- Download the latest Quicken Update. For instructions to download an update, choose Help menu > Quicken Help. Search for Update Software and follow the instructions.

Task 2: Deactivate Your Accounts at Farmers Insurance Group FCU on or after **Tuesday**, **February 16**.

- 1. Choose Tools menu > Account List.
- 2. Click the **Edit** button of the account you want to deactivate.
- 3. In the **Account Details** dialog, click on the **Online Services** tab.
- 4. Click **Deactivate.** Follow the prompts to confirm the deactivation.
- 5. Click on the General tab.
- 6. Remove the financial institution name and account number. Click **OK** to close the window.



7. Repeat steps 2—6 for each account to be deactivated.

Task 3: Re-activate Your Accounts at Farmers Insurance FCU/Farmers Insurance FCU-Business on or after **Tuesday**, **February 16**.

- 1. Choose Tools menu > Account List.
- 2. Click the **Edit** button of the account you want to activate.
- 3. In the Account Details dialog, click on the **Online Services tab**.
- 4. Click **Set up Now**.
- 5. Use **Advanced Setup** to activate your account.
- 6. Enter Farmers Insurance FCU/Farmers Insurance FCU-Business and click **Next**.
- 7. If presented with the Select Connection Method screen, select Express Web Connect.
- 8. Enter your User ID and Password. Click Connect.

NOTE: You may be presented with a security question from your **Financial Institutions** prior to receiving your accounts.

9. Ensure you associate the account to the appropriate account already listed in Quicken. You will want to select **Link to an existing account** and select the matching accounts in the drop-down menu.

IMPORTANT: Do **NOT** select **Add to Quicken** unless you intend to add a new account to Quicken. If you are presented with accounts you do not want to track in this data file, select **Ignore – Don't Download into Quicken**.

- After all accounts have been matched, click Next. You will receive confirmation that your accounts have been added.
- 11. Click Done or Finish.
